Cook Islands PM calls for Collaboration across Oceania Customs agencies at 26th Annual Conference



With a call for creativity and cooperation amongst Customs agencies around Oceania, the 26th Annual Oceania Customs Organization (OCO) conference got underway on the 29th July, 2024. Prime Minister Mark Brown of the Cook Islands emphasized the importance of regional cooperation in securing the future of the area. "Customs agencies play an indispensable role in promoting and facilitating trade, safeguarding our borders, and generating revenue for our governments," said Prime Minister Brown.

## PITAA/PFTAC Regional workshop on Tax Registration

A week-long workshop on taxpayer registration was held by the Pacific Technical Financial Technical Assistance (PFTAC) and the Pacific Islands Ta x Administrators Association (PITAA).

Tax administrator from the 15 Pacific Member Countries actively participated in this session, networking, and sharing their experiences.

Mr. George Mow (RIP), the-then PITAA Head of Secretariat spoke at the inauguration ceremony and emphasized the four major components of a typical tax system: registration, filing/lodgment, reporting/returns and payment. According to Mr. Mow, registration is the first step in the process, and if it is inaccurate, the three sectors cannot operate efficiently.

## Debriefing meeting with agencies, hosted by the UNODC Mission

To examine the mission's outcomes and potential future cooperation with the UNODC for support, the UNODC Mission convened a debriefing discussion with the agencies that met over the week on August 2, 2024.

Mr. Collie Brown, Pacific Advisor for the United Nations Office on Drugs & Crime said, "Tonga, like many countries in Pacific Islands Countries, is experiencing an upsurge in the scale of illicit trafficking (arms and weapons) into and through the country, often linked to transnational organized crime groups. The need to strengthen health and criminal justice institutions and to enhance national, regional and interregional cooperation could not be more urgent."

All government, non-governmental, and religious officials who attended the debriefing meeting were thanked by HM Prisons for contributing priceless insights to the conversation.

A monthly meeting with the Custom Brokers was held to discuss issues and clarify processes related to the release of consignments of importers under Customs control. The meeting included 'Alipate Tupou from Royco Ports and the Manager of Ports Security, Mr. Brisbane Lokotui, who attended to provide clarification. Following this meeting, a significant agreement was reached, and several loopholes within our service were identified that need to be addressed. there was strong emphasis on ensuring compliance at all levels and on maintaining due diligence processes within the Ministry and among Customs agents.
