Despite the fact that Hon. Mateni Tapueluelu had previously served as our minister, the ministry was delighted to welcome him back as our new minister.


### 2. New cashier at Queen Salote Wharf

This new cashier counter is designated to serve all QSW cargo, including cargo stored at the ROYCO Shed, vehicles, and Full Containers Loads cleared from QSW. **Revenue Mobilization in Samoa**

Discussions about the vital role that Customs administration plays in Free Trade Agreements (FTAs) began off the revenue mobilization. In the context of trade liberalization, Customs plays a crucial role in managing revenue collection. maintaining compliance, and facilitating trade. Among the topics covered in this event were methods for closing income gaps brought on by lower tariffs under Free Trade Agreements. The emphasis is on striking a balance between trade growth and revenue streams, which includes upgrading laws and systems, increasing capacity, and exchanging information.


We wish to inform the general public and Customs stakeholders that commencing on Monday 27/01/2025, the Customs office will no longer issue manual warrant number stamps on our payment receipts.

Instead, customers making payments to Customs for imports and exports clearance, will be issued a payment receipt from our Customs system which will have a unique reference number.

This new change will also allow Customs to pilot the setup of an additional cashier counter at the Royco Shed on Queen Salote Wharf to process payments for Queen Salote Wharf cargo only.

We hope that this initiative will help make our processes more efficient for the public as we strive to deliver on our commitment to serving you.
