## EXCISE TAX ACT 2007

(Section 3(1)(c))

### ORDER

**IN EXERCISE** of the powers conferred by section 3(1)(c) of the Excise Tax Act 2007, the Minister of Revenue Services, with the approval of Cabinet, hereby makes the following Order:

All materials imported by Tonga Cable Ltd for the purpose of setting up the international and domestic system for the Tonga-Fiji Submarine Cable Project shall be exempted from excise tax, PROVIDED that this Order shall –

- (a) come into force on the date of gazetting of this Order; and
- (b) expire on the date the international and domestic systems are ready for operation.

Made at Nuku'alofa on this 24th day of August 2012.
