### TU'UTU'UNI

'IHONONGAUE'AKI 'o e mafai kuo foaki 'e he kupu 5(3)(a) 'o e Lao ki he Tukuhau Ngaue'aki 2003, 'oku fakahokoai 'e he Minisita ki he Tanaki Pa'anga Hu Mai mo e Tute, 'i he loto ki ai 'a e Kapineti, 'a e Tu'utu'uni ko 'eni:

- (1) Kuo pau ke faka'atâ mei he tukuhau ngaue'aki 'a e ngaahi koloa ko 'eni 'i hono hu mai 'e he ngaahi pisinisi kuo ma'u laiseni pea ngofua ke ngaohi koloa fakalotofonua –
  - (a) misini ngaohi koloa, me'angae, ngaahi kongakonga 'o e misini;
  - (b) ngaahi naunau fo'u koloa; pea
  - (c) ngaahi me'a taumu'a ke fa'o ai 'a e koloa 'oku ngaohi fakalotofonua.
- (2) Kuo pau ke kamata ngaue'aki 'a e Tu'utu'uni ni 'i he 'aho 1 o Siulai 2017.

## CONSUMPTION TAX ACT 2003 (Section 5(3)(a))

### ORDER

**IN EXERCISE** of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister of Revenue and Customs, with the approval of Cabinet makes the following Order:

- (1) The importation by an approved licensed local manufacturer of the following goods shall be exempt from consumption tax –
  - (a) manufacturing machinery, equipment, their parts;
  - (b) raw materials for production; and
  - (c) packaging materials for their final locally manufactured products.
- (2) The commencement date of this Order shall be the 1<sup>st</sup> day of July 2017.
