

INTERNATIONAL CUSTOMS DAY 2023

THEME: "NURTURING THE NEXT GENERATION BY PROMOTING A CULTURE OF KNOWLEDGE-SHARING AND PROFESSIONAL PRIDE IN CUSTOMS"

On the 26th of January each year, the world commemorates International Customs Day. Each year, the World Customs Organization mark this day by setting a theme relevant to current global issues that is aimed at guiding and inspiring Customs administrations around the world as they work to address these common global issues. This year's theme is "Nurturing the next generation by Promoting a Culture of Knowledge-Sharing and Professional Pride in Customs".

This year, the Ministry marked the day with an official program highlighting the importance of the theme to the overall functions of the Ministry as well as the contributions of our key development partners towards building the capacities of Tonga Customs to enable the same. Officers of the Ministry were joined by Chief Guest, the Honorable Minister of Revenue & Customs and the Minister of Finance, Hon. Tiofilusi Tiueti, as well as representatives of Foreign Diplomatic representatives to the Kingdom of Tonga.



CONSULTATIONS & MEETINGS

Meeting with Tongan Police Commissioner - This meeting's aim was to discuss opportunities for enhanced cooperation and coordination efforts between Tonga Police and MORC.

Time Release Study (TRS) - Trade Division within the Ministry, in collaboration with the World Bank hosted a workshop on Time Release Study Exports. This workshop was led by the Ministry with assistance of experts Mrs. Theresa Morrissey and Mr. Allen Bruford from the World Bank and was attended by Shipping Agencies, Customs Brokers and exporters. The key objectives of this workshop were to measure the actual time for import/export/transit cargo to be released and/or cleared, to identify and document bottlenecks in the cargo released and/or clearance processes, recommended improvements to improve the efficiency and effectiveness of the cargo release and/or clearance processes and to implement approved performance improvements.

Clay Energy Training - Training about clearing some concerns about CT Payments and other issues raised from the attendees.

Ransomware Awareness - Two officers from Computer Emergency Response Team (CERT) conducted an awareness for MORC staff about a type of malware called Ransomware. It is a common and dangerous type of malware; it works by locking up or encrypting your files so that you can no longer access them. A ransom, usually in the form of crypto-currency, is demanded to restore access to the files, or to prevent data and intellectual property from being leaked or sold online. The purpose of this awareness is to inform government staff and also the people of Tonga, that Ransomware has attacked our Kingdom and to also enlighten us on the mechanisms to overcome this issue.

Prohibited importation of passenger vehicles over 15yrs old

This notice informs the general public and Tongans living abroad that importation of any passenger's vehicles older than 15 years (year 2008 or less) are no longer permitted. This notice has been given before but this serves as a polite reminder that <u>NO</u> passenger vehicles with a manufacturing date of more than 15 years are allowed for import. Please contact our main office of Tonga Customs directly at 7400-650 if you still require additional information on this matter.

Migration to ASYCUDA World System

To all Licensed Customs brokers and Individual goods declarants in Tongatapu. You are hereby notified that the Ministry of Revenue and Customs will not be accepting any CMS declarations with C11, C12 and C13 submissions after Friday 24th of February 2023.

All declarations submitted to Customs commencing on Monday 27th of February onwards must be via ASYCUDA World system.
